VIOLENCE REDUCTION

1. Ceasefire program fully implemented - NO!



PRIVATE PROFITEERING

1. No private prison contracts - NO!
2. In-source contracts for services - NO!
3. No acceptance of political contributions from private vendors - NO!



RE-ENTRY

1. Fair hiring policy - PARTIAL
Does not extend to formerly incarcerated
2. Reinvestment of criminal justice resources into transitional jobs - NO!
3. Transitional housing - NO!
Limited to low income areas. Largest housing group owned by Avalon, recently purchased by CCA
4. Voting rights restoration - NO!



RESPONSIBLE PROSECUTION

1. Report on racial disparities - NO!
2. Minimize length of parole and probation - NO!
3. Pre-trial services within 24 hours - PARTIAL
4. Limited prosecution of misdemeanor and limiting jail time to no longer than 365 days - NO!
5. No/limited Direct File transfer of Juveniles to Adult courts without judicial review - PARTIAL some cases
6. Safeguards on civil forfeiture - TBD



POLICE ACCOUNTABILITY

1. Implicit bias training for police officers - NO!
2. Civilian review board - PARTIAL
No subpoena power
3. Independent prosecutors for police shootings - NO!
4. Full transparency on use of force incidents - PARTIAL



SCHOOLS TO PRISON PIPELINE

1. Ban on suspensions/expulsions in elementary - NO!
We've signed on to the Texas Organizing Project's bill
2. Restorative justice programs in schools - PARTIAL
RJ programs in only 6 of its 227 public schools
3. Disciplinary code minimizes out of school suspensions, expulsions and arrests-- NO!
4. Limited role for police focused on safety - PARTIAL
Many schools have school policing & prison culture
5. Positive behavioral interventions & supports -PARTIAL



FEES AND FINES

1. Eliminate all non-restitution fines, fees, surcharge assessments, interest and collection charges - NO!
2. Justice related debt collected as a civil matter no criminal sanctions for non-payment - TBD
3. Base fines and collection practices on individualized assessment of ability to pay - NO!
4. Alternatives to fees, fines and incarceration, such as community service - NO!
5. Replace Money Bail with pretrial risk assessment, release on recognizance and other non-financial conditions - PARTIAL
Case by case at judge's discretion



KEEPING IMMIGRANT FAMILIES TOGETHER

1. No local participation in ICE detainers for immigration violations - NO!
2. Municipal IDs -NO!

DIVERSION



1. Pre-arrest diversion - TBD
2. Pre-charge diversion - PARTIAL
Our second chance courts are great programs however, limited in their geographical scope, funding, and person power
3. Shortening case processing time - TBD
4. Diversion into drug treatment - NO!
5. No lock up for status offenses, technical violations and other un-jailable offense - NO!
6. Diversion into mental health treatment - NO!
